GROUP ACTIVITIES

Identifying specific needs/challenges of different LIS sectors in Sri Lanka

The Strategic Planning and Strategic Directions Committee (SPSDC) of SLLA has launched a programme to identify specific needs or challenges of each LIS sector in the country. This will be the first exercise of phase 2 of the project, which aims to identify strategic directions or priorities of SLLA for the next 5 to 10 year period. Under the phase 1 of the project, SPSDC has completed the following.

- 1) Conducted a SWOT Analysis on the activities of the SLLA,
- 2) Identified best practices of leading Library Associations of the world,
- 3) Studied the guidelines and directions of IFLA on the subject,
- 4) Conducted an Opinion Survey to ascertain the views of SLLA membership and
- 5) Carried out a preliminary study on the contribution of SLLA towards different LIS sectors in the country during last 25 year (1990-2015) period.

SPSDC decided to appoint a set of sub committees to identify the specific needs and pinpoint the areas that need special attention of each LIS sector. From the above study (No.5), it was revealed that SLLA was not that successful in contributing meaningfully by addressing the major problems, constraints of different LIS sectors in the country. The SPSDC is keen to correct the deficiency by identifying weaknesses, challenges of each LIS sector and include them in strategic directions of the association. These sub committees comprise a number of SPSDC members and the Representative/Convener of the particular professional group of the SLLA. The committees have been empowered to incorporate a few other members if necessary.

National Environmental Information Centre (NEIC)

One of the main objectives of the Central Environmental Authority (CEA) is the provision of information and education to the public regarding protection and improvement of the environment. To fulfill this objective, CEA established a library in 1984, and named it the National Environmental Information Centre in 1993. The Centre has initiated a number of information services, developing and strengthening the library resources.

The National Environmental Information Centre plays different roles in performing its services.

- Acts as the centre of environmental information activities in Sri Lanka. Plays a key role in the organizations that are interested in environmental matters.
- Collects, organizes and preserves published and unpublished documents on environmental matters nationally and internationally.
- Functions as the focal point of international and regional environmental information systems which promote exchange and transfer of information.
- Entertains queries on information sources, persons and organizations and directs them to appropriate organizations.
- Serves as a distributing centre for environmental publications.

Target beneficiaries: Environmental Managers, Scientists, Researchers, Policy Makers, Academics, Industrialists, Entrepreneurs, Administrators, Technologists, Journalists, Information Scientists, Extension Workers, Students and the General Public.

Subject coverage: Environmental Management, Environmental Law, Environmental Conservation, Ecology, Environmental Information, Natural Resources, Natural Hazards, Environmental Degradation, Atmosphere, Human Ecology & Environmental related subjects such as health, industry, agriculture, urban planning, energy, construction, fisheries, transportation, irrigation and land use.

Library Services

Inquiry Service -The Centre operates an inquiry service for clients. Inquiries could be channeled by telephone, in writing or in person.

Reference Service - The Centre is open for reference during working hours. Photocopying facilities are provided when necessary.

Current Awareness Service - The staff of the CEA are kept informed of the material available in the library in their specific fields of interest, either manually or through e-mail. Environmental Content Service, New Accessions and Newspaper/Journal Index are used in providing this service.

Online Searching Service - The entire catalogue of the Centre and a large collection of newspaper and journal articles related to environment are available online.

Special Collections: CEA Publications; Environmental Impact Assessment Reports/ IEE Reports; Acts & Regulations related to Environment; Maps, Environmental Educational Materials, CD-ROMs, Pamphlets & Newsletters etc.

The National Environmental Information Centre established environmental libraries to satisfy the information needs of external users at regional and district level. Under this project three libraries were established at the Nature Field Centres of Roomassala (Galle District), Bellanwila – Attidiya (Colombo District) and Randenigala (Kegalle District) in the year 2012. These libraries maintain their collections focused on environmental subjects to support the environmental awareness programs conducted by the relevant Nature Field Centres. In the same year, NEIC established a school library in Walikanda MMV, Polonnaruwa and provided books, library racks and tables, a computer etc. worth Rs 1.2 million.

The keynote address by Prof. Sampath Amarathunge, Vice Chancellor, University of Sri Jayewardenepura, at the 55th Annual Sessions of the SLLA. (Excerpted)

We are all aware that this is the information age. I believe that the librarian is the most important person of this era because you are the manager of information and the library is the center of excellence. Your role has always been evolving through human history from guardian of knowledge and caretaker to what you are today. We have passed a historical era, both in Western and Eastern societies where books and the knowledge contained in them could not be accessed at all. In some cases, this right was the privilege of a few. But with the onset of the technological revolution making knowledge and information accessible to all there has been a dramatic change. This has reshaped and redefined your role as librarians because now you cannot claim that you are the sole guardians of knowledge and information. This is a fact.

Recently I read a guideline for an advocacy program launched by the American Library Association, which raised the following questions. Isn't Amazon.com going to put public libraries out of business? Why do school libraries need money for books when everything is online? Why do we need a campus library when students can do their research on the internet?

Technology has, while vastly changing the mode of information access, enhanced library and information services. It has however, left unresolved questions and challenges. We, the academic community of this country, have a crucial role to play in finding solutions and overcoming these challenges.

Francis Bacon, the 17th Century English philosopher and statesman, once said: "Reading Maketh a Full Man". In my opinion, our entire society has deviated from this noble habit. I lived in Japan for seven years and I was surprised at how much time people spent reading.

Let me tell you frankly that our libraries are almost isolated, university libraries as well. This is not due to lack of books. Our libraries have books worth millions of rupees. The problem is related to our adaptation, to our lack of innovation, to our perspectives and attitudes. How many of our libraries offer internet zones, Wi-Fi facilities, a modernized environment, clean wash rooms, efficiency, a friendly service and a lobby to discuss the chapter of a book? Rather, the experience of most of our people with libraries is of gloomy surroundings, iron bookshelves, dusty books, uncomfortable chairs and unclean washrooms. All these often project a cramped, dull, prisonlike environment. Can we then expect people to suddenly transform into an enthusiastic reading crowed, without making the necessary changes on our part first?

Initiatives have been taken in the University of Sri Jayewardenepura after I became the Vice Chancellor. All our initiatives are driven by this conviction that the library is the heart of the university. Hence, we have started a modernization project headed by the library committee. We are in the process of establishing a free internet lobby for students with fifty computers. We will make laptops available at the main counter so that a student – let us say a Samurdhi student – can borrow the laptop, complete his assignment in the reading room, and return the machine, just like he borrows a book for reference and returns it. Remember that, in the absence of such a facility, our students have to pay money to the outside cyber cafes. Additionally, we are also going to install Nescafe machines in the library, also to open the library at 5a.m.

We have never been hindered by the costs as far as the benefits they provide to the student community are concerned. So you see we are adopting a varied approach, catering to the diverse needs of our students in order to make the library a reader-friendly place. We need this diversification. With this we can make our students gather in the library. Without this we will make them gather at the Lipton roundabout. This is the power of change. Books or journals worth millions of rupees are not the only answer to our problems.

A staff with excellent qualifications having completed postgraduate degrees, having participated in foreign training, is not the answer. If our library is the same as the one we had in the past, then we have not realized our own worth. We have not given our maximum. Let me tell you that when I was the Dean of the Faculty of Management Studies and Commerce, I allocated a number of places for the students to engage in reading, to engage in their studies. These places are equipped with fans, Wi-Fi, washrooms, and other necessary amenities. Now I see that there is competition among students to get a seat there- you can see students even at 12 at their studies. These Halls have no designated names, but the students call them "Sampath Halls".

Therefore we have to always remember that we are in a technological era with a young generation of people who are always two-steps ahead of us with respect to knowledge and the usage of technology. They perceive the world rather differently from us. This is where the University Librarian has to get the booklist from the Heads of Departments on time. This is where our priorities should change. This is where we should re-think and re-design. In brief, this is where your role as the librarian has to be reshaped and redefined. Nobody does it for you. Or you should not wait till somebody else does so. You are already making a tremendous effort to adapt, innovate, and transform. But through some collectives efforts, some insight, some more commitment, you can do miracles, A miracles can really happen.
